Open to all eligible dogs. These tests are open to all breeds. Your dog must be at least 9 months of age (Farm Dog Test) 6 months of age for Fetch Dog Tests, and have an AKC number via one of the following:

AKC Registration Number

This number is provided to a dog owner via a registration certificate received from the previous owner, or via a puppy registration paper given to the new owner by the breeder.

Purebred Alternative Listing (PAL)

If a dog is purebred but an AKC Registration Number is not possible, owners can apply for a PAL number.

AKC Canine Partners Number

This number is given to either mixed breed dogs or a purebred.

Foundation Stock Service®(FSS) Number

This number is used for breeds whose status is currently in the foundational stage of being recorded into our registry and requires a copy of the dog's pedigree.

If you need help obtaining an AKC registration/PAL number/Canine Partners/FSS number, ATBA will have forms available on-site that you can fill out and send to AKC on the day of your entry.

For an additional \$3.00, ATBA will supply you with an envelope and stamp to send your application to the AKC on the day of your test(s).

The testing areas are fenced with cattle panel or 4 x 4 utility fencing. The testing areas are grass covered and have a slight incline.

AKC Rules, Regulations, Policies and Guidelines are available on the American Kennel Club website: www.akc.org.

Entries not on our Official AKC entry forms or photocopies without the Agreement and Rules are unacceptable. Entries will not be accepted without fees. No refund for duplicate entries or any other cause beyond the control of the Club after closing date. Returned checks do not constitute a valid entry. The ATBA treasurer will add a collection fee to the amount of each returned check. Canadian exhibitors must submit entries with international money orders in US funds. Telephone, telegraph, fax, e-mail and unsigned entries cannot be accepted. Changes, additions, or corrections to Entry Forms must be received in writing prior to the close of entries. The ATBA may decline entries for cause and may refuse to accept an entry or may remove any dog on account of disease, viciousness or other cause and no one shall have any claim or recourse against ATBA or any official thereof.

Entries sent by delivery services must be marked for delivery without a signature.
